



























## **MAZUMA EXPERIENCE - TEAM**

We are expanding the **Treasury Management Services** offered to our Members through our **Small Business Banking Team!** These services help businesses manage their cash flow and liquidity, coordinate access among multiple users, and monitor for and avoid fraud.

Our award-winning **Preferred Partner** program, in which we partner with local businesses to provide access and education around our financial products and services, now serves 28 businesses and continues to grow!

Our ongoing rollout of **contactless cards** continues to expand! Sometimes called **"tap to pay"** cards, contactless cards save time at the register and reduce security threats through data encryption.

In 2023, Mazuma Credit Union celebrated 75 years of service. From humble beginnings, we have grown to a credit union serving approximately 73,275 Members with 12 local branches, total assets of \$973 million, and capital of \$97 million as of December 31, 2023. Mazuma remains a solid, safe, and reliable financial partner committed to **Making Kansas City a Better Place to Live, Work, and Bank.** 

It was a challenging year for the entire financial industry and Mazuma was impacted by many of the trends that played out nationally. Interest rates remained elevated throughout the year. This had a negative impact on our mortgage loans, which were down by about 4% from the prior year. Additional interest income generated from loans and our investments was largely offset by the higher cost of funds and increases in our loan loss reserve. Checking and saving deposits also proved difficult to obtain in 2023. In response to this environment, Mazuma increased our total deposits by about 6% by offering very competitive rates on certificates of deposit.

During 2023, the cost of the funds we use to make our loans increased due to the larger amounts of certificates of deposit issued to our Members. Higher interest rates enabled our loan income to increase. This increase, however, was largely negated by the interest expense associated with certificates of deposit together with certain other expenses that exceeded our budget. Interest earned by our Members related to certificates of deposit increased by approximately 120% in 2023.

Mazuma's total income for 2023 approximated \$66 million, offset by total expenses of \$63 million. This resulted in income in excess of our expenses of about \$3 million, down about \$2.5 million in comparison to 2022.

As we look forward to 2024, we anticipate many of the same challenges we experienced in 2023. Future Federal Reserve decisions on interest rates will continue to impact our operations and financial performance. However, we have taken strategic steps to ensure we manage the current environment in a way that is responsive to our Members' needs. One important step is maintaining a solid capital position - 10.5% as of December 31, 2023 – which is well within the guidelines specified by our regulators.

Our liquidity remains strong and solid. As such, Mazuma remains well positioned to serve the needs of our Members and our community as we enter 2024.


